

You are developing a SQL Server Integration Services (SSIS) package that loads data into a data warehouse hosted on Windows Azure SQL Database.


You must combine two data sources together by using the ProductID column to provide complete details for each record. The data retrieved from each data source is sorted in ascending order by the ProductID column.

You need to develop a data flow that imports the data while meeting the requirements.



Database	Description
Transactional database	Recovery model: • Full Backup schedule:
	<ul> <li>Full database backup: midnight, daily</li> <li>Differential database backup: on the hour, every two hours starting at 02:00 hours except at 00:00 hours</li> <li>Log backup: every half hour, except at the times of full and differential backups</li> </ul>
Reporting database	Recovery model: • Simple Backup schedule: • Full database backup: 01:00 hours daily Differential database backup: 13:00 hours daily
	<ul> <li>Data updates:</li> <li>Changes in data are updated from the transactional database to the reporting database at 00:30 hours and at 12:30 hours</li> <li>The update takes 15 minutes</li> </ul>

The differential backup of the reporting database fails. Then, the reporting database fails at 14:00 hours.

You need to ensure that the reporting database is restored. You also need to ensure that data loss is minimal.
